Additional Local Rules

Unless otherwise noted, the penalty for breach of a local Rule is the General Penalty (Two strokes).

Main sponsor:

Preferred lies

When a player's ball lies in a part of the general area cut to fairway height or less the player may prefer the lie within one club-length. See Model Local Rule E-3 for details of how this must be done.

1. Out of Bounds (Rule 18.2)

- Out of bounds is defined by white posts and white lines. Where both white posts and white lines exists the white line defines the boundary of the course.
- Electric boundary fence. Model Local Rule E-7 is in effect:
If a player's ball lies on the course and within two club-lengths of the electric boundary fence on holes 6 and 14 the player may take free relief using the procedure in Rule 16.1 but based on this reference point: The point that is two club-lengths from the fence and an equal distance from the hole to the spot of the original ball.

2. Penalty Areas (Rule 17)

The red penalty areas to the left and behind of hole 8 and to the right of hole 9 are infinite.

3. Abnormal Course Conditions (Rule 16.1)

- Ant hills on the course are, at the player's option, loose impediments that may be removed under Rule 15.1 or ground under repair from which relief is allowed under Rule 16.1.
- Stone walls are integral objects. Loose stones may not be removed from a stone wall.

4. Caddies (Rule 10.3)

Model Local Rule H-1.1 is in effect: A player must not have a caddie during the round.

Additional Terms of Competition

1: Format

54 holes of stroke play 11-13 June with 18 holes each day and no cut.

2: Eligibility

Participants must

- be female
- an amateur golfer in accordance with the Rules and born 2006-2011
- be members of a Golf Club, National Golf Union, Federation or Association.
- have a maximum handicap of -4.4 at the closing time of entry.

3: Decision of ties

In the event of a tie for the first place after the final round, the champion will be decided by a hole-by-hole play-off. Holes used for such a play-off will be announced before completion of the final round.

4: Miscellaneous

- A: The winner gets an exemption to the 2024 Women's Amateur Championship (The R&A).
B: The top-3 players are qualified to ANNIKA Invitational USA 2025 provided they are not attending college/university.
C: Practice days are 9-10 June.
